- B. In compliance with the aforesaid MCA Circulars, this Postal Ballot Notice is being sent only through electronic mode to those Members, whose names appear in the Register of Members/Beneficial Owners maintained by the Depositories as on 07th July, 2023. The Postal Ballot Notice was also made available on the website of the Company at www.rajdarshanindustrieslimited.com. The hard copy of this postal ballot notice along with Postal ballot forms and pre-paid business envelope were not sent to the members for the postal ballot in accordance with the requirements specified under the MCA Circulars.
- C. The Company has appointed Central Depository Services (India) Limited to provide e- voting facility to the members of the Company to cast their votes through a secured electronic mode on the resolution to be transacted as mentioned in the Postal ballot notice, the report contains the details of E-voting only.
- D. The Company has completed the dispatch of postal Ballot notice by e-mail on 14th July, 2023 accordance with the MCA Circulars, no physical ballot notice was dispatched to the members.

- E. The requisite advertisements pursuant to Section 108 of the Companies Act, 2013 read with Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014, as amended and in compliance with Ministry of Corporate Affairs Circulars; were published in "Financial Express" (in English) and in "Jai Rajasthan" (in Hindi) respectively on 19th July, 2023, regarding dispatch of Postal Ballot along with Remote E-voting information and containing all the matters required under Companies Act, 2013 and relevant rules thereon.
- F. The cut-off date for determining the eligibility of the members to vote by remote e-voting for Postal ballot was 07th July, 2023. As on "Cut-off" date i.e. 07th July, 2023, there were 4784 shareholders.
- G. The Remote e-voting was kept open from 9.00 a.m. (IST) on Tuesday, 18th July, 2023, and remained open up to 5.00 p.m. (IST) on Wednesday, 16th August, 2023.
- H. The votes cast through remote e-voting were unblocked at 12:00 P.M. on 17th August, 2023 in the presence of two witnesses who were not the employees of the Company.
